# Conditions Koi Contest Holland Koi Show



### 1. Organisation

The Nishikigoi Vereniging Nederland (hence referred to as "N.V.N.") will organise the Koi contest in co-operation with Zen Nippon Airinkai.

#### 2. Registration/participation

Everybody can participate in the Koi contest. You can participate after registration. You will be officially registered after paying the deposit fee to the N.V.N. account. The deposit fee for hobbyists will be  $\in$  50,- or for traders  $\in$  125,-. This amount must be paid upon the entry on Thursday 15 August 2019. Each participant can enter a maximum of 13 Koi in competition with a maximum of 600 cm total Koi length, so the vats will not be overburdened. Only one vat per participant will be available. The minimum length is 100 cm. The registration fee's (payment due before 1 July 2019) are: Hobbyists (N.V.N. members)  $\in$  10,00 for each Koi; Hobbyist (non N.V.N. member)  $\in$  20.00 for each Koi; Traders  $\in$  20,00 for each Koi. The total registration fee will be increased by 10% if you register after the 1<sup>th</sup> of July 2019. All participating Koi should be Show-ready (stop feeding 7 days before the show), to prevent excessive pollution in the vats. This is for <u>your</u> own Koi's health. Every participating hobbyist will receive two tickets for all show days. Participation will be at your own risk. Only one registration for each address or trader is possible.

#### 3. Entries for the contest

Participants must enter their Koi on Thursday 15 August 2019 only, between 09.00 AM and 19.00 PM, admittance will be granted upon showing your proof of registration. By registering **the participant declares automatically that his fish are free of KHV or not have been in contact with fish contagious with KHV.** Each participant must be present personally at the registration stand on the show terrain. If a participating hobbyist has given his Koi to a trader, he should be personally present at the registration. Deviations are possible only after a written request is given a positive written confirmation by the management. After payment each participant will receive an original and a copy of the entry form. This consists of name of participant, kind of participant (hobbyist / trader), home country, numbers of Koi and vat number. Both the management and the participant will sign the registration form. The <u>copy is needed retrieve your Koi on Sunday</u>.

After registration the participant must follow the instructions given by the management team. The management team will take care of numbering and benching the Koi. All photos will become the property of N.V.N.

It will also be possible to bench online. The participant will receive by email a link with login codes. Also these photos become the property of the NVN and can be used in publications of the magazine KOI.

Participants are not allowed remove Koi <u>from /or put in</u>to the vats, or to place landing nets into the vats, not even for photographic purposes. If one wishes a photo, it is possible to ask the management, which will determine when <u>the organisation</u> will grant your request.

#### 4. Benching

All entered Koi will be benched in the following classes: Kohaku, Sanke, Showa, Utsurimono, Bekko, Koromo/Goshiki, Asagi/Shusui, Tancho (Tancho Kohaku, Tancho Sanke, Tancho Showa and Tancho Goshiki, incl. Doitsu en Ginrin), Kinginrin A (Go-Sanke), Kinginrin B (non Go-Sanke and excl. Tancho), Kawarimuji Mono (all one coloured Kawarimono like Chagoi, Soragoi, Benigoi, including single coloured Koi with the matsuba effect), Kawarimoyo Mono (all patterned multi-coloured Koi), Hikarimuji (mono) (all one coloured metallic Koi), Hikariutsuri (mono) (all metallic utsuri and Showa), Hikarimoyo (mono) (all the other more coloured metallic koi), Doitsu A (Go-Sanke) and Doitsu B (Non Go Sanke and excl. Tancho) . Within these classes, the Koi will be benched by size: **size 1**: 15 up to 20 cm, **size 2**: >20 up to 30 cm, **size 3**: >30 up to 40 cm, **size 4**: >40 up to 50 cm, **size 5**: >50 up to 60 cm, **size 6**: >60 up to 70 cm, **size 7**: >70 up to 80 cm and **size 8**: >80 cm. The benching team will bench the Koi. Decisions made by the benching team are binding. Sick Koi will be excluded from the contest and will be put in a separate vat; payments will not be refunded. The whole show will be supervised by a specialised vet.

### 5. Judging

1) Selection of the **Grand Champion**.

The **Grand Champion** will be chosen from the best Gosanke and the best Non Gosanke. Second will be the **Best (Non) Gosanke**.

#### The Grand Champion and Best (Non) Gosanke are excluded of the rest of the judging. N.B.: GO-SANKE = classes KOHAKU, SANKE en SHOWA!!! NON GO-SANKE = all other classes!!!

2) Selection of the Jumbo Champion from 80 centimetres and longer.

This is a benching award for the longest Koi and not a decision of the judges.

3) Remaining awards:

Round 1:

Selection of a first and second in each variety within their various size groups.

Round 2A:

Selection of the Best in Size drawn from each size group irrespective of Class.

#### Round 2B:

Selection of the Best in Class drawn from each class irrespective of size.

#### Round 3:

Selection of the:

- Mature Champion and Best Mature (Non) Gosanke (size 7 and 8) \*,
- Adult Champion and Best Adult (Non) Gosanke (size 5 and 6) \*,
- Young Champion and Best Young (Non) Gosanke (size 3 and 4) \*,
- Baby Champion and Best Baby (Non) Gosanke (size 1 and 2) \*.

Also in this round the selection of:

• Tategoi and Best Tategoi (Non) Gosanke \*

\*) The Champion will be chosen from the best Gosanke and the best Non Gosanke in the given size. Second will be the Best xxx (Non) Gosanke.

Following the ZNA there will also be introduced a Special Variety to promote one of the Varieties. This year it will be **Yamabuki Ogon**. A 1st, 2<sup>nd</sup> and 3<sup>rd</sup> prize will be given. Also will there be several friendship Awards. It is possible that the management team will discuss a different division of the prizes with the jury. All winners will be announced on the boards behind the vats on Saturday afternoon or earlier if possible.

Friday August 16<sup>th</sup> judging will be done by the judging team.

### 6. Prize giving

Prize giving will be held at 11.00 o'clock on Sunday August 18.

### 7. End of contest

After the prize distribution the management team will inform the participants at which time the de-benching will start. During de-benching the participant can retrieve his Koi by supplying the registration form to the treasurer and notify the de-bench team (after leaving the container of the treasurer). Only when you can produce your copy of the registration form will you be able to collect your Koi!!! It is not allowed to take your Koi out of the vats before the end of the prize distribution or before notifying the de-bench team. One will be excluded from joining the Koi contest from N.V.N. for an undetermined period if you do not respect this rule.

### 8. Global Data Protection Regulation (GDPR)

Within the framework of the European law General Data Protection Regulation (GDPR), the participant hereby gives permission to the Nishikigoi Vereniging Nederland (hereinafter referred to as N.V.N.) for the following actions:

- Taking pictures of the prize-winning fish by photographers from the N.V.N.
- Taking pictures of the participant (or delegate) during the Award Ceremony.
- Placing photos taken in the Magazine Koi of the N.V.N. or on the website of N.V.N. (nvn-koi.nl and / or hollandkoishow.nl)
- Placing the price list (including the name of the participant) in the Magazine Koi of the N.V.N. or on the website of N.V.N. (nvn-koi.nl and / or hollandkoishow.nl)

The N.V.N. will only perform the above-mentioned actions if you have given specific permission for this and will handle your details as a contest participant with the utmost care.

#### 9. General

The management team has the power to deviate from the rules. The management team will have a final role during all foreseen cases to the rules. The N.V.N. has the right to refuse traders or hobbyists participating the Koi contest, without any reason. The N.V.N. is not responsible for any damages, regardless of cause, to the Koi. All photos of the participating Koi can be used for publications. Traders are those (also hobbyists) who are occupied with selling/trading Koi or related articles (even with or without registration at the Chamber of Commerce). **Participants are not allowed to publish any kind of advertising on- or in the vats.** Participating is at your own risk.

10. Every participant should be familiar with these rules.

# **REGISTRATION FORM KOI CONTEST 2019**

Every year we get as an organization, the question from who are the fish in vat X or Y. The organization will never give the names of participants. Because there are people who don't want tell that Koi within a vat are theirs, but though there are also plenty of people who want to make known that the fish in a vat are from them. Therefore, we decided to give everyone the possibility to have the owner name, address and telephone number, shown at the vat. The address, etc. will be placed on the signs as soon as possible after the judging has finished. This gives traders the ability to advertise and hobbyists can come into contact with people who may be interested in a certain fish. Moreover, this possibility is an additional service of the N.V.N. and so completely free of charge. Keep in mind that the Koi can only be retrieved from the vat during the de-benching on Sunday.

#### How does this work?

You enter using the form below that you want to place your data at your vat. On a standard sign we put your name and the information you want (up to 4 lines) and places this after judging on the game board at the photos of your fish.

We want to make clear that only our standard signs are allowed at the vats, homemade signs or stickers will be removed immediately.

Hobbyists, we want to point out that not only your data can be viewed by any interested buyers, but also by thieves. We would expressly point out that the N.V.N. cannot be held liable for damage, theft etc. as a result of your attribution.
